CCC MEMBERSHIP CONTRACT

Parties

This membership contract is made between the Center Country Club (hereinafter the "CCC") and _____ (hereinafter "the member") (and collectively the "parties").

Payment

The member agrees that the CCC is immediately owed \$ _____ for:

_____ Junior Membership

_____ Social Membership

_____ Out of County Membership

The member further agrees that the monthly dues, kitchen assessment, driving range assessment, and all other charges made or approved by member will be paid monthly to the CCC for at least twelve (12) months following the date of this contract. In consideration of timely payment, the member will have access to all privileges associated with their membership status (full, junior, or social). The member agrees to provide a credit card or ACH authorization to CCC's bookkeeper for monthly payments to the CCC. The member agrees that the privileges associated with their membership status have been fully explained and the member understands the status, the privileges associated therewith, and the limitations thereof.

Payment Plan for Stockholder Membership _____ (member's initials if applicable)

The member and the CCC agree to establish a payment plan for the stock purchase. The member agrees to pay an additional one hundred dollars (\$100.00) per month for the next ten (10) months, in addition to the monthly charges referenced hereinabove. Once fully paid, the member will attain stockholder membership status and the additional one hundred dollar (\$100.00) charge will no longer be charged to the member's monthly bill.

Breach

If a member breaches this agreement for timely monthly payment, the CCC may declare the membership forfeit and/or accelerate the remaining amount owed on the contract due and payable immediately. Upon thirty (30) days notice, the CCC may use all legal remedies available to secure payment of the legally obligated debt from member.

Renewal

This membership contract shall renew each year upon the date noted below. The member must provide the CCC three (3) months written notice of cancellation before the renewal date, or the

membership will renew automatically for an additional twelve (12) months. Written cancellation notice must be sent to the CCC by certified mail, return receipt requested.

Governing Law

This contract shall be governed by and in accordance with the laws of the State of Texas. Any legal dispute regarding this contract shall be filed in Shelby County, Texas.

Severability

If any provision of this contract is found to be void and/or unenforceable by a court of competent jurisdiction, the remaining provisions will remain legally valid and enforceable.

Entire Agreement

This contract contains the entire agreement and understanding between the parties and supersedes all prior agreements, understandings, inducements and conditions, express or implied, oral or written, of any nature whatsoever with respect to the subject matter herein.

Amendments

The parties agree that any amendments made to this contract must be in writing and signed by all parties to this contract.
